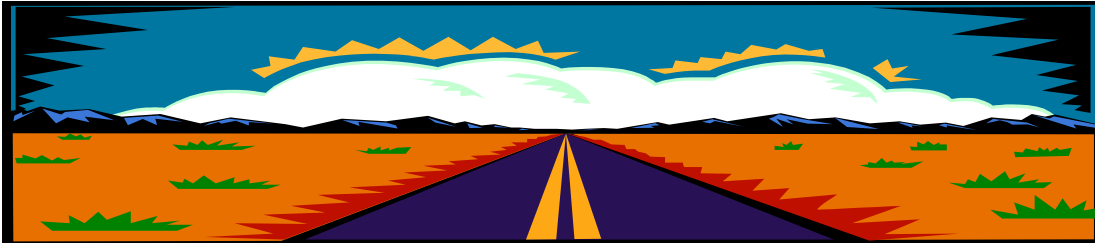

COURSE DESIGN: (NON CREDIT COURSE - DRIVER LICENSING ONLY)

- **CLASSROOM INSTRUCTION,**
- **DRIVING SIMULATION AND**
- **RANGE DRIVING WILL BE OFFERED.**

UPON COMPLETION OF THIS COURSE, STUDENTS WILL NEED:

- **3 HOURS OF ROAD SKILLS (BTW-BEHIND THE WHEEL) INSTRUCTION TO MEET VIRGINIA REQUIREMENTS OF LICENSING.**

“BTW” HOURS ARE SCHEDULED AFTER COURSE COMPLETION AND UPON AGE ELIGIBILITY (16 YEARS & 3 MONTHS). FEES FOR “BTW” INSTRUCTION ARE SEPARATE AND NOT INCLUDED IN THE TUITION COST OF THIS COURSE.

***VIRGINIA DRIVER LICENSING REQUIRMENTS**

- Students must be 15 ½ years old to be eligible for a Virginia Learner’s Permit.
- Students must hold a valid Virginia learner’s permit for 9 months, take a certified driver education course, complete the 45 hour parent /teen driving log and complete the road skills (behind the wheel) test for final licensing.

STUDENTS MUST BE AT LEAST 16 YEARS AND 3 MONTHS OLD TO BE ELIGIBLE FOR VIRGINIA LICENSING.
